Advocated evidenced-based policymaking. Set the annual criminal justice research, evaluation, and demonstration agenda. Exercised final authority over all grants, cooperative agreements, and contracts awarded by the NIJ. Planned annual budgets, led staffing decisions, and drove strategic planning and agency reorganization.

Planning & Leadership

- \$79+ million in annual funding for 140 projects accomplished as the first bureau to send all funding decisions to DOJ Office of Justice Programs review for upcoming calendar years.
- Garnered a higher level of quality in grant funding by awarding 40 grants for randomized controlled trials to rigorously evaluate programs.
- Bolstered the scientific rigor of the organization's research by formulating six interdisciplinary strategic research plans to produce hundreds of proposals in four years.
